The company strives to enrich the community and abroad through its numerous outreach programs and community performances including: Ballet by the Book, Flash Ballet, Discover Dance, and A Day at the Ballet. It also participates in international outreach through Ballet Ambassadors by working with global partners to bring ballet to underserved populations.

Its school, Ballet Palm Beach Academy, celebrating over 25 years, offers classes to students beginning at age 3. The company offers traineeships to talented academy students who wish to experience a professional dance career. 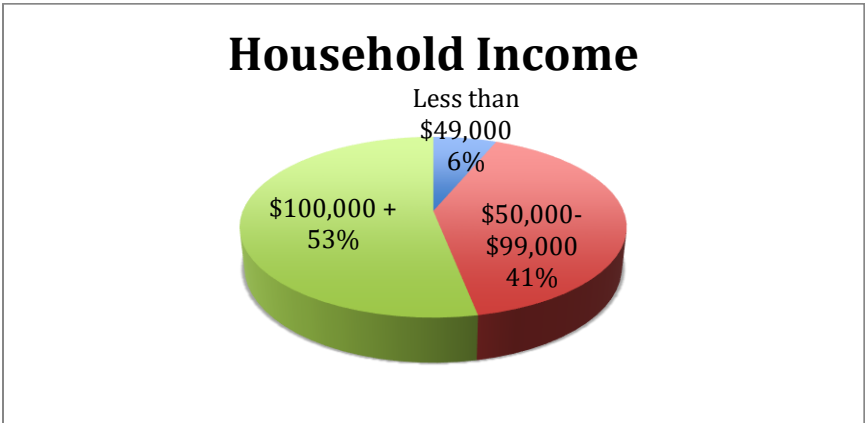




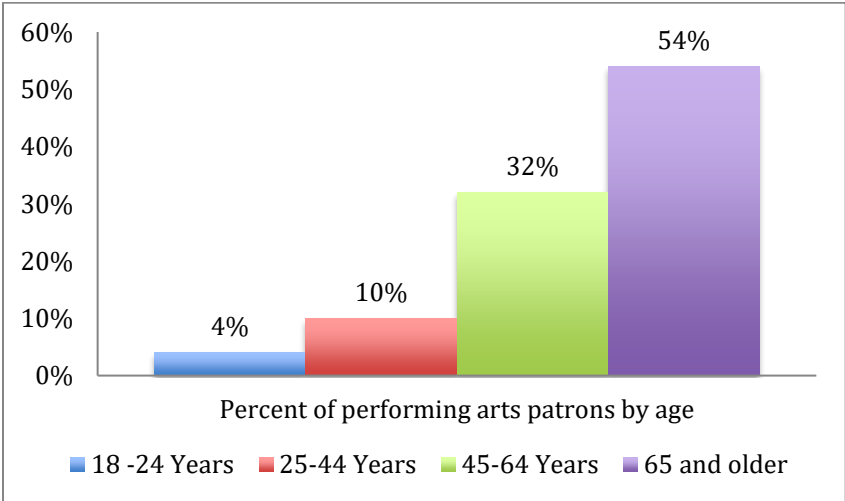
Audience Demographics
